

## Guidance for UKBMS recorders relating to Covid-19 – 2021 Season

The UKBMS partners (Butterfly Conservation, UK Centre for Ecology and Hydrology, British Trust for Ornithology and Joint Nature Conservation Committee) consider the welfare of staff, volunteers and partners of utmost importance and have taken the threat of Coronavirus (COVID-19) very seriously since its outset. We are working closely with other organisations involved in biodiversity monitoring in the UK and are constantly reviewing government guidance in relation to how COVID-19 impacts on our schemes.

It is our intention that the UKBMS will be operational throughout the 2021 season, and butterfly monitoring is permitted provided the following conditions are met at all times:

- **Recorders ensure they have permission to access the sites that they monitor.**
- **Recorders adhere to all Covid-19 restrictions issued by the government for the area where they live.**
- **Recorders take all sensible precautions to reduce the spread of Covid-19.**

Please see below for a summary of the current situation in each UK country with regards to travel and outdoor activity. We will endeavour to follow developments throughout the season, and keep our guidance updated, so please check our website at regular intervals <https://ukbms.org/health-safety>.

### England

The requirement to 'Stay at Home' ended on 29<sup>th</sup> March. There are no longer any defined limits on how far you can travel for exercise or recreation. However, you are still expected to minimise travel where possible, and plan ahead to avoid busy times and routes if you use public transport.

### Scotland

The requirement to 'Stay at Home' ended on 2<sup>nd</sup> April. Further to this, restrictions on travel beyond your local authority area, for the purposes of outdoor recreation and exercise, were lifted on 16<sup>th</sup> April.

We are aware that, in both **England and Scotland**, structured biological monitoring is considered to qualify under 'voluntary and charitable services' that cannot be done from home. However, you are still expected to assess and minimise the risks of disease transmission. We would only encourage recorders to take advantage of this exemption to travel further afield if you are monitoring priority species on key sites. ### Wales

The requirement to 'Stay Local' ended in Wales on 27<sup>th</sup> March. You can now visit any outdoor site that is open to the public for recreation. The restriction on crossing the English border was lifted on 12<sup>th</sup> April.

### Northern Ireland

The requirement to 'Stay at Home' was lifted on 12<sup>th</sup> April, but you are still required to 'stay local'. Although this is not well defined, previous guidance suggested that you should not travel more than 10 miles to exercise.

Additional Notes:

- Some public sites will be maintaining local restrictions to ensure social distancing measures are not compromised. Before you start monitoring, you must check that the landowners/site managers are happy for you to do so where appropriate.
- If your site or transect route are set up in such a way that would make it difficult to maintain social distancing throughout your walk (including the journey to/from the site) then you should not undertake butterfly monitoring on that site.
- If you carry out your survey alone, don't forget to refer to the lone working advice in the general [UKBMS Health & Safety guidance](#).
- If you carry out your survey with someone from outside your household, you must adhere to social distancing and follow relevant government guidelines as to the number of people allowed to gather.
- No-one should feel any pressure to undertake monitoring if they are not entirely comfortable doing so. The health of yourselves and your families is much more important.

We will continue to review all the advice from the UK Government and the devolved administrations and will update our guidance as and when appropriate.
